### Parent Agreement:

As the parent or guardian of this student, I have read the terms and conditions for the Clark County School District's Acceptable Use Policy. The instructional technology network of the Clark County School District represents a powerful educational resource which will allow your child to find information anywhere in the world. Your child will be able to connect to museums, major universities, national libraries, other schools, and students around the world. Use of the District's computer technology network resources for educational projects will assist in preparing your child for success in life and work in the 21st century.

From school your child can travel all over the world to gather information. It is possible that your child may find material on the Internet that you would consider objectionable. Although the District's Acceptable Use Policy outlines appropriate use of network resources in the school environment, we cannot guarantee that your child will not gain access to inappropriate material. The Clark County School District believes that the benefits to educators and students from access to network resources, in the form of information and opportunities for collaboration, far exceed any disadvantages.

Your child's teacher has reviewed the Clark County School District Acceptable Use Policy with his/her class and has explained the importance of using computer resources appropriately. We want to make you familiar with these rules as well. Before your child can access the network resources, both you and your child must read the Clark County School District Acceptable Use Policy and complete a Network Access Form.

This signed form grants your child permission to access, produce, video conference, and communicate information on the network resources. Violating the Acceptable Use Policy may result in loss of network privileges and/or other District disciplinary measures.

Please note that your child's work may be published on the District's computer network resources, including, but not limited to, World Wide Web pages. If student work is identified, only the first name, grade, and school should be listed. Parent/guardian and other permissions must be obtained in accordance with the Acceptable Use Policy. Additionally, your son or daughter may participate in video-conferencing or network activities that utilize the Internet or other global computer networking resources.
